The L. P. Gas Commission requires proof of insurance on a Commission proprietary certificate of insurance form as of November 1, 2005. Insurance requirements are \$1,000,000 in each class of insurance required by Commission rules. If the certificate of insurance is not received on or before the expiration date of your current certificate of insurance, a citation will be issued. Permit holders must "Cease and Desist" L.P.
