**CLASSES 1, 4, AND 6 PERMIT HOLDERS ARE REQUIRED TO PAY THE MARKET DEVELOPMENT ASSESSMENT. PLEASE SEE**

AS A REMINDER TO ALL NEW APPLICANTS AND SUPPLIERS, Application requests shall be ADMINISTRATIVELY GRANTED by the office of the Director upon compliance with the Louisiana Administrative Code, Title 55, and the Louisiana Revised Statutes of 1950, as amended. Requirements vary by permit class but include submission of a formal application, payment of fees, and may include employee certification, sketch of installations, and/or inspections of transport vehicles. Under the authority of the Director, the applicant may engage in the services of a consultant to assist in the application process. The application process is finalized by the Commission ratifying the permit at their first subsequent meeting after the applicant has completed all necessary requirements.
