submission of a formal application, permit fee, filing fee, certificate of insurance on approved proprietary form, and may include employee certification, sketch of installations, and/or inspections of transport vehicles. The application process is finalized by the Commission ratifying the permit at their first subsequent meeting after the applicant has completed all necessary requirements. TRAINING AVAILABLE
