FIRES AND ACCIDENTS

RELATED:

No related fires reported for the month of February, 2004.

UNRELATED:

FIRE: Macon Ridge Propane Service Inc. reported a fire destroyed the residence of Brandon Carroll, Winnsboro, LA. The cause of the fire is unknown, possibly from a cigarette. It is unknown if there was loss of product or injuries.

ACCIDENT: LacoX, Inc. reported an **at-fault** accident in which the driver got too close to the shoulder when the shoulder gave way and the truck rolled over on its side. Damage to right front fenders and

passenger door.

ACCIDENT: Coast Propane Inc. reported an **at-fault** accident in which the driver did not see car pulling in behind him while he was backing up. Damage to front bumper of other driver's car.

ACCIDENT: Petron, Inc. reported an **at-fault** accident in which driver attempted to changed lanes while there was a vehicle traveling in the same lane. The other vehicle then swerved to avoid being hit, losing control and striking the semi. There was no loss of product and three injuries of passengers reported.

ACCIDENT: Petron, Inc. reported an **at-fault** accident in which driver changed lanes, striking another vehicle and left the scene.

ACCIDENT: Petron, Inc. reported anot at-fault accident in which driver struck a piece of pipe that fell off of a tractor trailer.Damage to underside of vehicle.

ACCIDENT: Hercules Transport, Inc. reported a not at-fault accident in which driver was stopped in traffic and another vehicle failed to control speed and struck transport from the rear. Damage to rear bumper.

INCIDENT: Ferrellgas reported a not at fault incident-Notification of flaring off of a stationary 5,800 gallon tank.

INCIDENT: Ferrellgas reported an **at-fault** incident in which a distribution hose on re-seller's tank leaked gas.
