CLASS 6X - YOU ARE REQUIRED TO SUBMIT A COMPLETE ADDRESSES AND STORE NUMBERS ALONG WITH YOUR PERMIT RENEWAL. THE PERMIT RENEWAL IS \$150.00.**

AS A REMINDER TO ALL NEW APPLICANTS AND SUPPLIERS, Application requests shall be ADMINISTRATIVELY GRANTED by the office of the Director upon compliance with the Louisiana Administrative Code, Title 55, and the Louisiana Revised Statutes of 1950, as amended. Requirements vary by permit class but include submission of a certificate of insurance on approved proprietary form, and may include employee certification, sketch of installations, and/or inspections of transport vehicles. Under the authority of the specified L.P. Gas business immediately as a licensed permit holder with the Commission. The application process is finalized by the Commission ratifying the permit after the applicant has completed all necessary requirements.
