MAY 2006 FIRES AND ACCIDENTS

RELATED:

THERE WERE NO RELATED FIRES TO REPORT FOR THE MONTH OF MAY 2006.

UNRELATED:

THERE WERE NO UNRELATED FIRES TO REPORT FOR THE MONTH OF MAY 2006.

ACCIDENT: Propane Industrial Gases reported an **at-fault** accident between a bobtail and tractor trailer. Details of probable cause of accident were not reported. Employee received minor injuries. Damage reports included tractor right, front fender and bumper and bobtail being totaled. No tank was damaged and no loss of product.

INCIDENT: Onealgas reported a **not-at-fault** incident which occurred at the Delhi Guest Home. They received a phone call concerning ice formation on the tank. Proper authorities were also notified. Inspector Britton found the bleeder screw on the tank had been opened and quickly corrected the situation. There was minimal loss of product, no fires, and no injuries. It was undetermined how the bleeder screw was loosed.
