TRANSPORT/ DELIVERY TRUCK REGISTRATIONS AND INSPECTIONS

No annual registrations will be issued out of the Baton Rouge office after April 30, 2000. A transport vehicle (bobtail or semi) may not be used in Louisiana after April 30, 2000, until it has been registered and inspected by the L. P. Gas Commission. After April 30, 2000 all effected permit holders <u>must contact their L. P. Gas Inspector</u> to get their vehicles inspected prior to their use in the State of Louisiana. All actions in regard to the registration and inspection must be initiated by the permit holder. Substantial penalties may be assessed for non-compliance with the rules. Any questions or concerns contact the L. P. Gas Commission office or L. P. Gas Inspector.

NOTICE TO ALL PERMIT HOLDERS TRANSPORTING LPG

The L. P. Gas Commission and the Louisiana Propane Gas Association will jointly sponsor training and safety schools on Wednesday, August 16 and Thursday, August 17, 2000 in Alexandria, LA at the Holiday Inn on MacArthur Drive. There will be two (2) concurrent sessions on both days. One session is being done by the Texas Railroad Commission and entitled "Operating a Cargo Tank Motor Vehicle in Metered Delivery Service". The other session by the Louisiana L. P. Gas Commission entitled "The Code of Federal Regulations". These schools will be of particular interest to all transportation personnel.

SCHOOL BUS/MASS TRANSIT VEHICLE REGISTRATIONS AND INSPECTIONS (propelled by LPG)

All school buses/mass transit vehicles propelled by LPG must be registered and a safety inspection performed by an LPGC inspector prior to August 1, 2000. The rules governing these vehicles will be strictly enforced. <u>SUBSTANTIAL PENALTIES MAY BE ASSESSED FOR NON-COMPLIANCE</u>. <u>QUESTIONS OR CONCERNS CONTACT LPGC OFFICE OR AN LPGC INSPECTOR</u>.
