CLASS 6X - YOU ARE REQUIRED TO SUBMIT ALL LOCATIONS WITH COMPLETE ADDRESSES AND STORE NUMBERS ALONG WITH YOUR PERMIT RENEWAL. THE PERMIT RENEWAL IS REQUIRED FOR EACH LOCATION.**

**CLASSES 1, 4, AND 6 PERMIT HOLDERS ARE REQUIRED TO PAY THE MARKET DEVELOPMENT ASSESSMENT. PLEASE SEE YOUR INSPECTOR FOR INSTRUCTIONS.**

AS A REMINDER TO ALL NEW APPLICANTS AND SUPPLIERS, Application requests shall be ADMINISTRATIVELY GRANTED by the office of the Director upon cor requirements as set forth in the Louisiana Administrative Code, Title 55, and the Louisiana Revised Statutes of 1950, as amended. Requirements vary by permit class but include application, permit fee, filing fee, certificate of insurance on approved proprietary form, and may include employee certification, sketch of installations, and/or inspections of authority of the Director, the applicant may engage in the specified L.P. Gas business immediately as a licensed permit holder with the Commission. The application process is completed by ratifying the permit at their first subsequent meeting after the applicant has completed all necessary requirements.
