Insurance requirements are \$1,000,000 in each class of insurance required by Commission rules. JULY 2006**CONDEMNED/UNCONDEMNED SYSTEMS**

Amerigas Propane LP representative, Mary Helen Patterson, permanently **condemned** the following LP Gas Tank:
1. 250 gallon, Beaird Tank, located at 350 Gill Rd, Boyce, LA. Serial # JG34106. Hole in bottom of tank was causing it to leak gas. Authorities contacted, emergency personnel responded, and incident resolved without fire, injuries, and only 10 gallons of gas lost.

JULY 2006**FIRES AND ACCIDENTS**

RELATED: THERE WERE NO RELATED FIRES TO REPORT FOR THE MONTH OF JULY 2006.

UNRELATED:

FIRE: Amerigas Propane LP, Many, reported a fire destroyed Budderbeans Grill, Zwolle, LA. Probable cause deemed electrical. Neither injuries nor loss of product reported.
