IMPORTANT NOTICE: 2001 REGISTRATION TRUCK TAG RENEWALS

New registrations and the required safety inspection, after April 30, 2001 must be performed by a Commission Inspector, **"BEFORE USE IN LOUISIANA"**. All, by mail, renewal registrations must have the required safety inspection performed by the **"INSPECTION DUE BY"** date or by August 1, 2001 whichever comes first. **PLEASE ADHERE TO THESE RULES TO AVOID A VIOLATION.** Options are available on the "mailed in" renewals that are **NOT BEING USED** in Louisiana and on equipment that has been registered and disposed of. Call the Baton Rouge office or read the rules of the Commission for the procedure. Reciprocal inspections are acceptable from Arkansas and Texas only on transports.

IMPORTANT NOTICE: 2001 SCHOOL BUS/MASS TRANSIT REGISTRATIONS

Units not registered with 2001 decals **may not be fueled** with L. P. Gas. Safety inspections must be performed by an L. P. Gas Inspector on all registered units. **A list of outstanding safety inspections will be published in the September 2001 AD letter and they "WILL NOT BE ALLOWED TO BE FUELED"**.

FIRES AND ACCIDENTS

One dealer reported a related fire that destroyed a pick-up truck used on a farm. The truck caught on
