Requirements vary by permit class but include submission of a formal application, permit fee, filing fee, certificate of insurance on approved

proprietary form, and may include employee certification, sketch of installations, and/or inspections of transport vehicles. Under the authority of the Director, the applicant may engage in the specified L.P. Gas business immediately as a licensed permit holder with the Commission. In an attempt to transfer propane from customers' tank to delivery truck, proper connections were made and a leak was discovered at fittings. When the fittings were in the process of tightening, a bushing screwed into the tank gave way, blowing out the excess flow and other piping along with 500 gallons of liquid propane product. Proper authorities were notified. No fatalities were reported. Injuries were reported.
