AS A REMINDER TO ALL NEW APPLICANTS AND SUPPLIERS, Application requests shall be ADMINISTRATIVELY GRANTED by the office of the Director upon completion of the application process, as set forth in the Louisiana Administrative Code, Title 55, and the Louisiana Revised Statutes of 1950, as amended. Requirements vary by permit class but include submission of a fee, certificate of insurance on approved proprietary form, and may include employee certification, sketch of installations, and/or inspections of transport vehicles. Under the provisions of the specified L.P. Gas business immediately as a licensed permit holder with the Commission. The application process is finalized by the Commission ratifying the application after the applicant has completed all necessary requirements.
