FIRES AND ACCIDENTS

Two dealers reported two fires that destroyed a camp and damaged a business. The fires are believed to have been caused by lighting a cigarette by a leaking propane tank and by a hose on a truck with an open valve then starting the tow truck. There was loss of product and injuries were reported.

Numerous dealers reported nine unrelated fires and three unrelated accidents. The fires destroyed five homes, damaged two homes, damaged one mobile home, and extent of damage to one mobile home was unknown. The fires are believed to be caused from electrical problems, a forest fire, a bug bomb, a trash fire and one fire the cause was unknown. There was no loss of product and a fatality and injuries were reported.

Three dealers reported accidents involving their company vehicle. One accident occurred when a dealer was pumping propane and the relief valve popped off and sprayed owner in the face, another accident occurred when their company vehicle was struck by a vehicle that ran a stop sign, and the last accident occurred when their company vehicle rear-ended a vehicle. There was no loss of product and injuries were reported.
