After April 30, all truck renewals, new registrations as well as the inspection must be performed through a Commission Inspector. ALSO, AFTER APRIL 30, NO INSPECTIONS, RENEWALS OR NEW REGISTRATIONS WILL BE HANDLED BY MAIL. Upon receipt of the transmittal with the tag attached the inspection must be performed within 90 days of the "Inspection Due By" date or by August 1, 2000 whichever comes first.
